 - II. NUMERICAL ABILITY AND TEST OF REASONING - 40 QUESTIONS
 - III. ENGLISH LANGUAGE - 30 QUESTIONS
 - IV. BASIC COMPUTER KNOWLEDGE - 10 QUESTION
- **All questions are in OBJECTIVE TYPE MULTIPLE CHOICE QUESTIONS and the duration of the examination is 2 hours**
- **Each right answer carries one mark and for each wrong answer half mark (-½) will be deducted**
- **Only those ranked first 25 in the written examination will be called for Skill test.**
- **Where two or more candidates secure same mark in the Written test, the candidate who secured more mark in Numerical Ability and Test of reasoning will be ranked prior to others. Where two or more candidates secure same mark in the written test and same mark in Numerical Ability and Test of reasoning, the candidate who secured more mark in English will be ranked prior to others. Where two or more candidates secure same total marks in the written test as well as above mentioned papers the candidate who secured more mark in General Knowledge and Current Affairs will be ranked prior to others.**
- **SC/ST candidates and Handicapped Ex-service men are eligible for re-imbusement of second class/Sleeper class rail fare or bus fare, chargeable by the shortest route from Railway station/bus stand nearest to their place of residence or from which they actually perform the journey which ever is nearer, to the place of written test and back to the same station provided that the fare of the first 30 km in both cases is borne by the candidates and the re-**

imbursement restricted to the fare in respect of the balance of distance exceeding 30 km., both ways. However, TA is not admissible to those who are already working in State or Central organizations. TA Claim Form for the eligible candidates (SC/ST and Handicapped Ex-servicemen) will be uploaded in the Web site shortly.
