GENERAL CONDITIONS:

1. Experience in the **Relevant field** means the experience in the thrust areas of C-MET in the field of electronic materials, such as, extraction of precious metals from e-waste, electronic ceramics, sensors & actuators, nano materials and devices, materials for energy including aerogel, graphene, materials and devices for battery, super capacitors, solar cells, fuel cells etc., polymer nanocomposites, flexible materials, thick and thin film materials and devices, integrated electronic packing including microwave materials, LTCC, u-LTCC, terahertz materials and devices. Any new materials for Indian electronic industry/ strategic sector/ up-coming commercial electronic applications in the country. Materials having societal relevance and applications, design and development of materials, alloys, compound semiconductors, fabrication of their devices, etc.
2. The prescribed essential qualifications are minimum and the mere possession of the same does not entitle candidates to be called for interview. 9. Those employed in Govt. departments/ PSUs/ Autonomous Bodies should apply through proper channel.
