SYLLABUS AND SELECTION METHODOLOGY FOR RECRUITMENT OF OFFICE ASSISTANT II LEVEL 5 (Rs.29200- 92300)

Selection of the candidate shall be through WRITTEN TEST & SKILL TEST ONLY AND NO INTERVIEWS WILL BE CONDUCTED

The written exam will be conducted online/offline (manual) which will be consisting of 100 objective type multiple choice questions (MCQs) of one mark each for a total of 100 marks.

The written Examination will be divided into five Sections and each Section will carry 20 marks as follows:-

Section A – Numerical / Arithmetical Ability	20 marks
Section B - Test of Reasoning	20 marks
Section C - English Language & Comprehension	20 marks
Section D - Basic Computer Knowledge	20 marks
Section E - General Knowledge & Current Affairs	20 marks

Level of examination: GRADUATION

Minimum qualifying marks: The qualifying marks for selection will be 70% marks in aggregate and not less than 50% in each Section (i.e. Minimum qualifying marks per Section is 10 marks).

Duration of the examination will be 2 HOURS. The language of the exam will be English only.

Each right answer carries one mark and for each wrong answer half mark (1/2) will be deducted

Where two or more candidates secure same mark in the Written test, the candidate who secures more mark in Numerical/Arithmetical Ability will be ranked prior to others. Where two or more candidates secure same mark in the written test and same mark in Numerical/Arithmetical Ability, the candidate who secures more mark in Test of reasoning will be ranked prior to others. Same pattern will be followed in the order of English Language, Basic Computer Knowledge and General Knowledge & Current Affairs.

Only those ranked first 25 in the written examination will be called for Skill test in Typing @ 35 words per minute. Typing test is only a qualifying test and hence the marks scored in typing test shall not be reckoned in drawing up the merit list.
