#### Detailed pattern of the Exam:

The written exam will be conducted online/offline (manual) which will be consisting of 100 objective type multiple choice questions (MCQs) of one mark each for a total of 100 marks. There will be negative marking of 0.25 marks for each wrong answer given. The format of the question paper will be of Objective Type-multiple choice questions only. Duration of the examination will be 90 minutes. The language of the exam will be English only.

The written Examination has been divided into four Sections and each Section will carry 25 marks as follows:-

Section A - Mental Ability/ reasoning	25 marks
Section B - Arithmetical Ability	25 marks

#### METHODLOGY OF SELECTION

MODE OF SELECTION: Mode of selection will be based on written examination only and there will be no interview.

**The Selection Process:** The qualification prescribed is the MINIMUM requirement and the same does not automatically make candidates eligible for WRITTEN TEST. Based on the academic performance in the 10<sup>th</sup> standard and 10+2 standard, initial screening may be conducted and a higher cut-off percentage may be adopted to short-list candidates for taking-up written test. The written test will be conducted at HYDERABAD ONLY. The criteria adopted by the initial screening committee will be notified in the website. The call letters will be sent only by e-mail.

Those who secure minimum 50% marks in written test in each Section and aggregate of 70% marks will be considered for empanelment in order of merit, subject to number of vacancies notified. The final merit list would be determined on the basis of total score obtained by the candidates in the COMPUTER BASED WRITTEN TEST/ MANUAL WRITTEN EXAMINATION.

In case of more than 1 candidate scoring highest mark, (a) the final merit will be determined on the basis of highest mark scored among the candidates in the Mental Ability/ reasoning(Section A) will be selected, (b) even then more than 1 candidate tie up, then final merit will be determined on the basis of highest mark scored among the candidates in BOTH MENTAL REASONING(Section A) AND ARITHMETICAL ABILITY(Section B) will be selected and (c) Even then more than 1 candidate tie up with highest mark, then final merit shall be based on the older among the candidate as per their "date of birth" as illustrated below:
