SCREENING, WRITTEN TEST SYLLABUS AND INTERVIEW PATTERN:

In the case of written test followed by interview, only top 10 candidates will be called for the interview in each stream. The syllabus of the written test will be as per Diploma/Degree standard with multiple choice questions. Results will be declared immediately.

2. Candidates are expected to bring their application/bio-data and produce original educational mark sheet & cast certificate etc. at the time of screening. In case the certificates/mark sheets etc. have not collected from colleges/present employer, a **custodian certificate** from the respective authorities should invariably produced to the Screening Committee at the time of verification of certificates, failing which the candidate will not be allowed to attend the interview.
