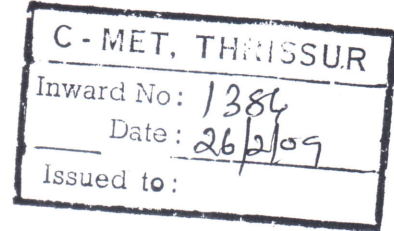

(ii) They shall come into force on the date of issue of this Notification.
 2. Number, Classification and Scale of Pay: - The number of the posts, their classification and the scales of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed thereto.
 3. Method of recruitment, age limit and other qualifications: - The method of recruitment, age limit, qualifications and other matters relating to the said posts shall be as specified in Columns 7 to 12 of the said schedule.
 4. Disqualifications: No person
 - (a) Who has entered into or contracted a marriage with a person having a spouse living, or
 - (b) Who, having a spouse living, has entered into or contracted a marriage with Any person,

Shall be eligible for appointment to the said post.



Provided that the Society may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this Rule.

5. **Power to relax:** Where the Competent Authority is of the opinion that it is necessary or expedient to do so, it may, by order, for reasons to be recorded in writing and subject to approval of the said reasons by the following authorities:
- (i) Executive Director in respect of Group C posts.
 - (ii) Vice-Chairman, Governing Council in respect of Group B and A posts.

The above-mentioned authorities can relax any of the provisions of these rules with respect of any class or category of persons.


6. Power to downgrade or upgrade any post, as a functional requirement, rests with Governing Council.
