Section 2 - Eligibility Criteria

Pre-qualification criteria:

- The Bidder's firm should have existence for a minimum of 5 years. (Enclose Company Registration Certificate)
- 2. The Bidder should belong to either class 1 or class 2 supplier distinguished by their "local content" as defined by recent edits to GFR. They should mention clearly which class they belong to in the cover letter.
 - a) Class 1 supplier: Goods and services should have local content of equal to or more than 50%.
 - b) Class 2 supplier: Goods and services should have local content of equal to or more than 20 % and less than 50%.
- 3. Quote should come only from Indian Original Equipment Manufacturer

- (OEM) or their Indian authorized distributor.
- 4. The quotations should be on FOR- C-MET, Hyderabad basis in INR only.
- 5. Bidders offering imported products will fall under category of Non-local suppliers. They cannot claim themselves as Class-1 local supplier/Class-II local suppliers by claiming the services such as transportation, insurance, installation, commissioning, training, and other sales service support like AMC/CMC etc as local value addition.
- 6. Purchase preference as defined by the recent edits to GFR (within the "margin of purchase preference") will be given to Class-1 supplier.
- 7. The Bidder must not be blacklisted/banned/suspended or have a record of any service- related dispute with any organization in India or elsewhere. A declaration to this effect has to be given as per Annexure 3.
- 8. The bidder should sign and submit the declaration for Acceptance of Terms and Conditions as per Annexure 4.
- 9. After-sales service and support, please provide a list of the following:
 - (i) List of installations (minimum 3) with contact persons contact mobile nos. have to be provided along with quotation.
 - (ii) List of service centres (please indicate the one that will support CMET)
 - (iii) Number of company trained engineers at each service centre.

Section 3 - Terms and Conditions

A) Bid Security Declaration:

The bidder has to sign a Bid Security declaration accepting that if the bidder withdraws or modifies its bid during the period of validity i. e., not less than 120 (one hundred and twenty) days from the bid due date or if the bidder is awarded the contract and fails to sign the contract or to submit a performance security before the deadline defined in the request for bid documents, the bidder will be suspended for participation in the tendering process for the tenders of C-MET, Hyderabad for a period of one year from the bid due date of this tender. The bid security declaration shall be submitted as per format (Format for Bid Security Declaration).

B) Submission of Tender:

- 1. All documentations in the tender should be in English.
- 2. Tender should be submitted in two envelops (two bid system).
 - a. Technical Bid (Part-A) Technical bid consisting of all technical details and check list for conformance to technical specifications. The technical proposal should contain a technical compliance as per format (Technical Compliance Statement).
 - b. Commercial Bid (Part-B) Indicating item wise price for the items mentioned in the technical bid, as per the format of quotation provided in tender, and other commercial terms and conditions.

- 3. The technical bid and price bid should each be placed in separate sealed covers, superscripting on both the envelopes with the tender no. and the due date. Both these sealed covers are to be placed in a bigger cover which should also be sealed and duly superscripted with the Tender No, Tender Description & Due Date.
 - 4. The SEALED COVER superscripting tender number / due date & should reach The Administrative Officer (A), C-MET, IDA Phase III, Cherlapally, HCL Post, Hyderabad 500 051 on or before due date mentioned in the tender notice. In case due date happens to be holiday the tender will be accepted and opened on the next working day. If the quotation cover is not sealed, it will be rejected. E-mail/Fax bids will be rejected
 - All technical queries are to be addressed to the person identified in "Section 1 Bid Schedule" of the tender notice.
 - The item is required for research purpose, and C-MET is a DSIR registered institution and hence is eligible for concessional GST rate (i.e. GST @ 5%). While submitting the price quote, this point must be taken care of. For getting concessional GST rate certificate, successful bidders must submit, a formal request together with Invoice copy and Purchase order copy.
 - 7. GST/other taxes, levies etc., are to be indicated separately. The BIDDER should mention GST Registration and PAN in the tender document.
 - 8. If price is not quoted in Commercial Bid as per the format provided in tender document, the bid is liable to be rejected.
- 9. C-MET reserves the right to accept or reject any bid and to annul the bidding process and reject all bids at any time prior to the award of contract, without incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders.
- 10. Incomplete bids will be summarily rejected.

C) Cancellation of Tender:

Notwithstanding anything specified in this tender document, C-MET, in its sole discretion, unconditionally and without having to assign any reason, reserves the rights:

- a. To accept OR reject lowest tender or any other tender or all the tenders.
- b. To accept any tender in full or in part.
- c. To reject the tender, offer not confirming to the tender terms.

D) Validity of the Offer:

The offer shall be valid 120 Days from the date of opening of financial or commercial bid.

E) Evaluation of Offer:

- 1. The technical bid (Part A) will be opened first and evaluated.
- 2. Bidders meeting the required eligibility criteria as stated in Section 2 of this document shall only be considered for Commercial Bid (Part B) opening. Further, agencies not furnishing the documentary evidence as required will not be considered.
- 3. Pre-qualification of the bidders shall not imply final acceptance of the Commercial Bid. The agency may be rejected at any point during technical evaluation or during commercial evaluation. The decision in regard to acceptance and / or rejection of any offer in part or full shall be the sole discretion of C-MET, Hyderabad and decision in this regard shall be binding on the bidders.
- 4. The award of contract will be subject to acceptance of the terms and conditions stated in this tender.
- 5. Any offer which deviates from the vital conditions (as illustrated below) of the tender is liable to be rejected:
 - a. Non-submission of complete offers.
 - b. Receipt of bids after due date and time and or by email / fax (unless specified otherwise).
 - c. Receipt of bids in open conditions.
- In case any BIDDER is silent on any clauses mentioned in these tender documents, C-MET, Hyderabad shall construe that the BIDDER had accepted the clauses as of the tender and no further claim will be entertained.
- 7. No revision in the terms and conditions quoted in the offer will be entertained after the last date and time fixed for receipt of tenders.
- 8. Lowest bid will be calculated based on the total price of all items tendered for Basic equipment along with accessories selected for installation, operation, pre-processing and post processing, optional items, recommended spares, warranty, annual maintenance contract. C-MET is looking for the most cost-effective solution of obtaining a new tool. Vendors are encouraged to propose all avenues, including but not limited to buy back of the existing tool, turnkey upgrade of existing tool or purchase of a new tool.

F) Pre-requisites:

The bidder will provide the prerequisite installation requirement of the equipment along with the technical bid.

G) Warranty:

The complete system is to be under warranty period of minimum 1 year standard warranty + 4 years extended warranty from the date of final acceptance at C-MET (year wise breakup value should be shown in the commercial bid) Vendor should include cost of any spares that are expected to be needed during the warranty/extended warranty period, including electronics, subcomponents, and software. Vendors can assume usage of 1000-1500 hours/year for this calculation If the instrument is found to be defective, it has to be replaced or rectified at the cost of the bidder within 30 days from the date of receipt of written communications from C-MET, Hyderabad. If there is any delay in replacement or rectification, the warranty period should be correspondingly extended.

H) Annual Maintenance Contract:

An annual maintenance contract for a period of at least 3 years post warranty should be provided as per format as an optional item on completion of warranty period of 5 years (1 year standard warranty + 4 years extended warranty).

The AMC costs will not be considered towards classifying the domestic nature (class 1 or class 2) of the vendor (see eligibility criteria in section 2).

I) Purchase Order:

- The quantity of the items in tender is only indicative. C-MET, Hyderabad reserves the right to increase/decrease the quantity of the items depending on the requirement.
- 2. If the quality of the product and service provided is not found satisfactory, C-MET, Hyderabad reserves the right to cancel or amend the contract.

J) Delivery, Installation and Training:

The bidder shall provide the lead time to delivery, installation and made functional at C-MET, Hyderabad from the date of receipt of purchase order. The system should be delivered, installed and made functional within 60 days from the date of receipt of purchase order. The supply of the items will be considered as effected only on satisfactory installation and inspection of the system and inspection of all the items and features/capabilities tested by the C-MET, Hyderabad. After successful installation and inspection, the date of taking over of entire system by the C-MET, Hyderabad shall be taken as the start of the warranty period. No partial shipment is allowed.

The bidder should also arrange for technical training to the local facility technologists and users.

K) <u>Liquidated Damages:</u>

The delivery period quoted should be realistic. The delivery period so quoted and mentioned in the order is the essence of the order/contract. In case of delay in delivery of material as per the delivery schedule, Liquidated Damage @ 0.5% per week or part thereof on the undelivered portion subject to a maximum of 10% of the contract value shall be levied. Wherever, installation and commissioning is also involved, the supply will be deemed to have been completed only when the entire stores is supplied, installed and accepted.

L) Performance Security Deposit (PSD):

- Within 21 days of receipt of the notification of award/PO, the Supplier shall furnish Performance Security (PS) [also known as Bank Guarantee] for the amount specified in the purchase order. It is an option to the Purchaser either to submit single Bank Guarantee/FD etc as detailed to cover both supply, installation and commissioning (as indicated in PO/WO) and warranty/extended warranty period or two BGs one each to cover supply and warranty/extended warranty separately. The validity shall be as stipulated in PO plus 60 days.
- The proceeds of the performance security shall be payable to the Purchaser as compensation for any loss resulting from the Supplier's failure to complete its obligations under the Contract.
- The Performance Security shall be denominated in Indian Rupees for the offers received for supplies within India and denominated in the currency of the contract in the case of offers received for supply from foreign countries or in equivalent Indian Rupees in case the Performance Security is submitted by the Indian Agent.
- The Performance security shall be in one of the following forms: (a) A Bank guarantee issued by a Nationalized/ Scheduled bank in the form provided in the bidding documents. Or (b) A Banker's cheque or Account Payee demand draft in favour of the purchaser. Or, (c) A Fixed Deposit Receipt pledged in favour of the Purchaser.
- The performance security will be discharged by the Purchaser and returned to the Supplier not later than 60 days following the date of completion of the Supplier's performance obligations, including any warranty/extended warranty obligations, unless specified otherwise, without levy of any interest.
- In the event of any contract amendment, the supplier shall, within 21 days of receipt of such amendment, furnish the amendment to the performance security, rendering the same valid for the duration of the contract, as amended for further period of 60 days thereafter.
- The performance security must be submitted within 21 days. However, the Purchaser has the powers to extend the time frame for submission of Performance Security (PS). Even after extension of time, if the PS is not received, the contract is liable to be cancelled provided that the purchaser, on

being satisfied that it is not a case of cartelization and the integrity of the procurement process has been maintained, may, for cogent reasons, offer the next successful bidder an opportunity to match the financial bid of the first successful bidder, and if the offer is accepted, award the contract to the next successful bidder at the price bid of the first successful bidder.

Whenever, the bidder chooses to submit the Performance Security in the form of Bank Guarantee, then he should advise the banker issuing the Bank Guarantee to immediately send by Registered Post (A.D.) an unstamped duplicate copy of the Guarantee directly to the Purchaser with a covering letter to compare with the original BG for the correctness, genuineness, etc.

M) Payment Terms:

Our standard payment term is 100% payment within 30 days against receipt, installation, commissioning, training and acceptance of material in good condition by NEFT/RTGS subject to submission of BG for 3% of contract value covering warranty period including extended warranty period, if any.

Special Condition: The stipulated delivery date for completion of all activities to be performed by the supplier under contractual obligations i.e., supply of equipment/machinery and erecting & commissioning including all the civil, electrical works, if any under the contract.

N) Statutory Variation:

Statutory Variation in taxes and duties, or fresh imposition of taxes and duties by State/Central Governments in respect of the items stipulated in the contract (and not the raw materials thereof), within the original delivery period stipulated in the contract, or last unconditionally extended delivery period shall be to C-MET's account. Only such variation shall be admissible which takes place after the submission of bid. No claim on account of statutory variation in respect of existing tax/duty will be accepted unless the tenderer has clearly indicated in his offer the rate of tax/duty considered in his quoted rate. No claim on account of statutory variation shall be admissible on account of misclassification by the supplier/contractor.

O) Disputes and Jurisdiction:

Any legal disputes arising out of any breach of contract pertaining to this tender shall be settled in the court of competent jurisdiction located within the city of Hyderabad, India.

P) <u>Force Majeure:</u>

The Supplier shall not be liable for forfeiture of its performance security, penalty or termination for default, if and to the extent that, its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.

For purposes of this clause, "Force Majeure" means an event beyond the control of the Supplier and not involving the Supplier's fault or negligence and not foreseeable. Such events may include, but are not limited to, acts of the Purchaser either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.

If a Force Majeure situation arises, the Supplier shall promptly notify C-MET in writing of such conditions and the cause thereof. Unless otherwise directed by C-MET in writing, the Supplier shall continue to perform its obligations under the Supply as far as it is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure.

Q) General:

- 1. All amendments, time extension, clarifications etc., within the period of submission of the tender will be communicated electronically. No extension in the bid due date/time shall be considered on account of delay in receipt of any document(s) by mail.
- 2. The bidder may furnish any additional information, which is necessary to establish capabilities to successfully complete the envisaged work. It is however, advised not to furnish superfluous information.
- 3. The bidder may visit the installation site before submission of tender, with prior intimation.
- 4. Any information furnished by the bidder found to be incorrect, either immediately or at a later date, would render the bidder liable to be debarred from tendering/taking up of work in C-MET, Hyderabad.
