Incubation facility for Start Ups on E Waste Management Expression of Interest

C-MET has established a Centre of Excellence (CoE) on E-waste Management to promote resource efficiency & circular economy. One of the objectives of the CoE is to impart training to start-ups in the area of E-waste Management. Towards fulfilment of this objective, C-MET invites expression of interest from entrepreneurs/individuals who have clear vision on a problem statement and keen to build start-ups on e-waste management and seek technical mentorship/handholding from C-MET experts for utilising the “incubation facilities” on effective e-waste management.

Additional details:

- Party is required to approach CoE on E-waste Management for enrolment for availing the facilities stated above. Registration format is given below.
- After getting associated with C-MET, the start-up shall be encouraged to register with “Start up Mission”, Government of Telangana / Start up, MeitY, Government of India following the prescribed procedure.
- The Start-up should be enrolled for a specific single area of activity which must include one of the activities in e-waste recycling.
- Start-up has to sign Non-Disclosure Agreement with CoE
- The Start- up has to pay Rs. 25,000/- per month for a minimum period of three months
- CoE will house the Start- up inside C-MET campus and shall provide necessary basic infrastructure
- CoE will extend training in the areas of E-waste management activities as enlisted in the advertisement to the Start- up for a period of 15 days exclusively for its employees (not more than 2)

- CoE will also hand-hold in the technical aspects of the e-waste management for the area chosen by the Start-ups after the training up to 3 months from the date of completion of the training
- If the Start-up requires operation of machineries for any reason(s), charges for the utilities shall be applicable
- If Start-ups want to acquire any technology developed under CoE, approved ToT charges shall be applicable
- Each Start-up can have maximum of two persons who have to be enrolled at the time of registration
- C-MET will not be able provide accommodation during the training period, as C-MET does not have Guest House facility
- The Start-ups will be entertained in the assigned area of activity for which they were trained by C-MET
- If the Start-ups come with their own idea and if any technology is realized with the help of CoE, the IPR will be shared equally
