GENERAL CONDITIONS:

- 1. The applicant must be a Citizen of India.
- 2. Experience in the Relevant field means the experience in the thrust areas of C-MET in the field of electronic materials, such as, compound semiconductor materials, ultra-high purity materials, recovery of secondary materials from ewaste, electronic ceramics, sensors & actuators, nano materials and devices, materials for energy including aerogel, graphene, materials and devices for battery, super capacitors, solar cells, fuel cells, Additive manufacturing (3D printing), Quantum dots & Materials, polymer nanocomposites, flexible integrated electronic packing including microwave materials, LTCC, u-LTCC. Materials and devices for high frequency (MW, mm & THz) applications, 2D and Nano-Structured materials and devices, Plasmonics, Thin, thick film, bulk, single crystal based materials & devices, Meta materials/PBG/Devices based on light matter interaction etc. Any new materials for Indian electronic industry/ strategic sector/ up-coming commercial electronic applications in the country. Materials having societal relevance and applications, design and development of materials, alloys, compound semiconductors, fabrication of their devices, etc.
- 3. All the above posts are as per the central government pay structure as extended to C-MET and carry allowances like house rent allowance, transport allowance and children's educational allowance, etc. These posts are governed by National Pension Scheme (NPS) of Govt. of India and will be eligible for other benefits like medical, LTC etc., as per C-MET norms.
- 4. The prescribed essential qualifications are minimum and the mere possession of the same does not entitle candidates to be called for interview. If the number of applications received in response to Advertisement is large, C-MET may restrict the number of candidates to be called for interview to a reasonable limit through a shortlisting process based on some well-defined criteria which may include possessing of desirable qualifications and / or experience prescribed in the advertisement and/ or qualifications/ experience in a particular field as per the specific requirement of C-MET. Only short-listed candidates will be called for interview. Mere fulfilling of requirement as laid down in the advertisement does not qualify a candidate to be called for interview. - 5. Number of years of experience indicated for the post is after obtaining the specified qualification for the post. Period spent on acquiring essential qualifications shall not count towards experience. - 6. All applicants must fulfill the minimum educational qualifications essentially required for the position and other conditions stipulated in the advertisement. They are advised to satisfy themselves before applying for the post.
- 7. At present the place of posting will be as indicated in the advertisement. However, the persons selected shall be liable to be transferred to any of the C-MET labs situated anywhere in India.
- 8. Minimum age is 18 years for all posts. Upper age limit is relaxable for SC/ST/OBC (non creamy layer)/ Persons with Benchmark Disabilities (PwBDs) and other categories as per orders of Govt. of India issued from time to time. In the case of PwBDs, relaxation in age limit shall be applicable irrespective of the fact whether the post is reserved or not, provided the post is identified suitable for PwBDs.
- 9. Candidates are not required to submit to C-MET either by post or by hand the printouts of online applications/other documents.

Candidates are advised to submit only one single online application for each post. If more than one application is submitted, the most recent one complete in all respects will be reckoned. Fees paid against one application number shall not be adjusted against any other application.

Candidates are advised to submit the online application well in advance without waiting for the last date.

Before applying online, candidates may keep the following ready:

- a. Credit Card/Debit Card/Net Banking Details
- b. Scanned image of Photograph and signature
- c. Scanned copies of Date of Birth, Certificate of Essential Educational Qualification, Caste Certificate (SC/ST/OBC) if applicable, Category Certificate (PWD or any other) if applicable, NOC & other documents
