- **SYLLUBAS OF WRITTEN EXAMINATION**
 - I. **CORE SUBJECT (ELECTRONICS) - 80 QUESTIONS**
 - II. **ANALYTICAL/ NUMERICAL ABILITY AND TEST OF REASONING - 20 QUESTIONS**
- **All questions are in OBJECTIVE TYPE MULTIPLE CHOICE QUESTIONS and the duration of the examination is 2 hours**
- **Each right answer carries one mark. No negative mark will be awarded for wrong answer.**
- **The written examination will be followed by skill test and will start at 14.00 hrs. Skill test is based on Go/No Go criteria (at least 50% mark needed to qualify in skill test). The rank list will be purely based on the written test marks.**
- **Where two or more candidates secure same mark in the Written test, the candidate who secured more mark in Core subject will be ranked prior to others. Where two or more candidates secure same mark in the written test and same mark in Core subject, the candidate who secured more mark in Skill test will be ranked prior to others.**
- **SC/ST candidates and Handicapped Ex-service men are eligible for re-imburement of second class/Sleeper class rail fare or bus fare, chargeable by the shortest route from Railway station/bus stand nearest to their place of residence or from which they actually perform the journey which ever is nearer, to the place of written test and back to the same station provided that the fare of the first 30 km in both cases is borne by the candidates and the re-imburement restricted to the fare in respect of the balance of distance exceeding 30 km., both ways. However, TA is not admissible to those who are already working in State or Central organizations. TA Claim Form for the eligible candidates (SC/ST and Handicapped Ex-servicemen) will be uploaded in the Web site shortly.**

- **Communication other than requested, phone calls will not be entertained.**
- **All updates and information will be notified in C-MET website : www.cmet.gov.in only and it is the responsibility of the candidates to monitor the website frequently.**
