#### Job Profile:

The present assignment is purely temporary in nature.

Selected candidate has to conduct experiments in laboratory, pilot plant and also in the recycling industries when deputed. He/she has to generate data, report to supervisors during experiments and pilot plant trials. He/she has to strictly adhere to safety requirements. The selected candidate has to travel anywhere in the country as and when required.
