# Technical specifications for High temperature sample holder with heating unit

- A sample holder suitable for dielectric measurements (two probe) over the temperature range between R.T to 1000°C
- Sample holder should be designed for solid specimens having diameter between 8 to 20 mm and thickness between 0.5to 3mm.
- The sample holder should have a spring loaded mechanism for holding the specimens rigidly during the H.T measurements.
- Two platinum discs as a bottom and top electrode having a diameter of ≥20 mm should be provided in the sample holder. The faces of the platinum discs of should be highly flat to ensure better contact between the test specimens.
- Proper electrical insulations (preferably of recrystallized alumina) and shielding should be provided suitable for high temperature measurements.
- A suitable thermocouple to measure the temperature between R.T to 1000°C having an accuracy of ±1°C should be placed near to the specimen under test.
- A suitable heating arrangements capable of heating till 1000°C should be provided and designed according to the sample holder design.
- The heating unit should provide better temperature control and accuracy of  $\pm 1^{\circ}$ C.
- The heating unit should have PID based temperature controller withmicro-controlled thyristor to ensure better temperature uniformity and accuracy.

- 1. The tender shall be submitted by either the Principal/OEM itself, or by Agent/Dealer on behalf of the Principal/OEM, but both cannot bid simultaneously for the same product in the same tender. In case of failure to supply within the time specified in the Purchase order, a penalty/LD of 0.5% of the total value per week or a part thereof shall be levied subject to a maximum of 10% in respect of items which are not supplied. - 19. If the deliveries are not maintained and due to that account Procuring Entity (C-MET) is forced to buy the material at your risk and cost from elsewhere, the loss or damage that may be sustained there by will be recovered from the defaulting supplier.
- 20. Dispute clause: Any dispute relating to the enquiry shall be subject to the jurisdiction of the court at Thrissur only.

## 23. Evaluation of Tenders

- a. All tenders are evaluated strictly on the basis of the terms and conditions incorporated in the tender document and those stipulated by the tenderers in their tenders. Tenders that do not meet the basic requirements specified in the bid documents are treated as unresponsive and ignored.
- b. Evaluation is based only on the conditions included in the tender document and any other condition will not form the basis of this evaluation.

- c. **Evaluation of eligibility/qualification Criteria:** Procuring Entity will determine, to its satisfaction, whether the tenderers are eligible, qualified and capable in all respects to perform the contract satisfactorily. Tenders that do not meet the required eligibility/qualification criteria prescribed will be treated as unresponsive and not considered further.
- d. **Evaluation of Technical Suitability:** The description, specifications, drawings and other technical terms and conditions are examined with respect to the specifications Procuring Entity. Minor exceptions/deviations may be waived provided they do not constitute any material deviation and do not have significant financial impact and, also, would not prejudice or affect the ranking order of the price bid. Exceptions/deviations should not grant the tenderer any undue advantage vis-à-vis other tenders and Procuring Entity.
- e. **Evaluation of Commercial Conditions:** The commercial conditions quoted by the Tenderer are evaluated to confirm that all terms and conditions specified in the Tender have been accepted without reservations by the tenderer. ## f. Evaluation of Financial Bids and Ranking of Tenders in general:

- i. The financial bids of only responsive and technically accepted tenders will be opened and evaluated.
- ii. If the price bid is ambiguous so that it may very well lead to two equally valid total price amounts, then the bid should be treated as unresponsive.
- iii. Sometime certain bidders offer suo motu discounts and rebates after opening of the tender(techno-commercial or financial). Such rebates/discounts should not be considered for the purpose of ranking the offer but if such a firm does become L1 at its original offer, such suo motu rebates can be incorporated in the contracts. - iv.
