 All Tax invoices shall invariably bear your GST Registration No. (GSTIN) and the applicable GST rates. In the absence of which, the invoice(s) shall not be processed for payment.

6. Our standard delivery term is FOR, C-MET. In case any vendor offers delivery term of Ex-works, Packing and Forwarding charges if any should be indicated separately either as

a percentage of the quoted rate or as a Lumpsum amount.

 We are exempted from the payment of Customs Duty as per Notification No. No. 51/96-Customs dated 23.07.1996 and necessary exemption certificate shall be issued upon request.
