- 1. Qualification Criteria: The Contracting agency shall;
 - (i) have GST registration;
 - (ii) have at least three years of experience in such type of work in Government organizations or reputed private institutions,
 - (iii) have liaison office in the state of Kerala; preferably in Thrissur
- 2. **Scope of the work**:- To maintain the IP Communication Server (EPABX) Model: NEC SV 8100 configured as 64 Analog Extensions, 16 co Line and One Operator Console, installed in C-MET, Thrissur, in good working condition.
- 3. Works to be performed:
 - i) to attend to minor and major breakdowns
