1. Please submit the Technical Details/Catalogue/Data Sheets.

2. The offer should be valid for a period of 90 days from the date of opening of Tender.

3. Please send the quotations ONLY in 'SEALED COVER' indicating our tender enquiry No. and due date by Hand/speed post/courier so as to reach us on or before the due date & time. C-MET will not be responsible for any postal delays.

4. E-Mail/fax quotations 'WILL NOT BE ACCEPTED'.

5. All Tax invoices shall invariably bear your GST Registration No. (GSTIN) and the applicable GST rates. In the absence of which, the invoice(s) shall not be processed for payment.

6. Our standard delivery term is FOR, C-MET. In case any vendor offers delivery term of Ex-works, Packing and Forwarding charges if any should be indicated separately either as

a percentage of the quoted rate or as a Lumpsum amount.

### **Specifications of Metal Granulation System**

Metal cutting/granulation system is required for conversion of Zinc ingot into less than 3 mm diameter shorts/pellets. The system should consist of i) Vacuum chamber, ii) Vacuum unit, iii) Furnace and electrical control panel with following specifications.

i) Vacuum Chamber

Material: SS 304

Size: ID 300 mm x Height 350 mm x wall thickness 5 mm

Top removable cover with control rod in the centre

Four ports shall be welded to the chamber

- a) Vacuum port: ø 40 mm x 100 mm L
- b) Power port: ø 100 mm x 50 mm L
- c) View port: Ø 50 mm x 75 mm L
- d) Thermocouple: ø 15 mm
- e) A platform (50 mm thick) shall be welded to the chamber for taking the load of graphite assembly
- f) An insulation board (50 mm thick) shall be provided on the top of the plat form
- ii) Vacuum Unit
  - a) Vacuum pump: Oil sealed double stage rotary pump. Capacity: 150 LPM
  - b) Vacuum measurement: Digital Pirani gauge and gauge head
  - c) Isolation valve (Manual) with interconnecting SS Bellow
  - iii) Furnace and electrical control panel

Furnace power: 3 kW at 75 V and 40 A

PID temperature controller for controlling the furnace temperature

K-type Thermocouple for temperature measurement

Control Panel: main MCB, Control switches & indicating lamps, vacuum pump

ON/OFF, etc.

Scope of work: Fabrication, testing, erection and commissioning at C-MET, Hyderabad


